He has written for a wide variety of publications, from The Detroit News and Human Events to Transport Topics and Pet Age.

ERC Board Elections Set for January Meeting



Eastside Republican Club members will elect 2021 officers and board members at their regular meeting, Tuesday, Jan. 19, 2021, during our January kickoff meeting via Zoom at 7:30 p.m.

Only regular ERC members current in dues are allowed to vote. Members will make nominations from the floor.

As provided by the bylaws, all seven members of the Eastside Republican Club executive board shall be elected at the Annual Meeting by plurality vote of the Regular Members present and voting. Voting by proxy shall not be allowed.

Offices are chair, vice chair, secretary and treasurer. There is no term limitation on the four elected officers, and they may succeed themselves in office.

The board includes three at-large members. No board member may serve more than one term as an at-large executive board member during any two-year period.

Any member with a question about the responsibilities of a specific office or position is encouraged to contact chairman Dave Schumacher or other officer.



Hope for Republicans: Is There a Dem Jim Jeffords Out There? By The Ballenger Report

OK, we know the Democratic nominees won the two Georgia runoff elections for the U.S. Senate on Jan. 5, knocking off a pair of Republican incumbents.

That should give Democrats control of the chamber and their longsought "trifecta"—the Presidency, a majority in the U.S. House of Representatives, and now an apparent 51-50



edge in the Senate by virtue of Vice President Kamala Harris' tie-breaking vote.

But wait! What about Jim Jeffords? Does anyone remember him and what he did 20 years ago?

In June of 2001, three months before 9/11, Jeffords of Vermont did something no other U.S. Senator has ever done, before or since—he changed party affiliation (from Republican to Independent, but caucusing with the Democrats), thereby flipping control of the chamber from a GOP majority to Democratic control. It's the only time in U.S. history that a single senator changing party affiliation has resulted in a reconstituted U.S. Senate.

The point of this article is, the scenario today means the stage is set for it to happen again—except the other way around!

In January 2001, the Senate found itself in a 50-50 tie, just like today. At that time, the new Vice President was Republican Dick Cheney who as the presiding officer had the tie-breaking vote, enabling Republicans to organize the chamber. That was all well and good for five months, but then Jeffords, a lifelong Republican, bolted the GOP caucus in June.

When he walked over to the Democratic side, that meant there was a new Democratic majority, 51-49, and Cheney's tie-breaking vote was no longer required. The Democrats took over and continued to control the chamber for another 18 months—until Republican Jim Talent won a special contest in Missouri and the GOP solidified its advantage in the November, 2002, general election regaining its majority in the chamber.

Flash forward to 2021. It could happen again. Let's say Joe Manchin, a lonely Democratic U.S. Senator swimming in a red sea of Republicanism in West Virginia should decide he's so out of step with his party colleagues that he might just as well make it official and join the GOP.

The governor of West Virginia has already done that.

Manchin has said he would never vote to get rid of the filibuster, which scuttles the Democrats' plans to do exactly that if they could get 51 votes to pull it off. You can be sure Manchin would be amply rewarded by grateful Republicans with a committee chairmanship, just as Jeffords was rewarded by Democrats back in 2001.

Let's see what happens.

Dems have their Squad. Republicans now have their "Freedom Force."


The GOP is touting the Force, made up of four incoming freshmen, all of whom lived part of their lives in a communist country and are fierce advocates for free markets and free minds.

How Did it Happen? Look Beyond Election Day 'Irregularities'

During the Jan. 6 joint session of Congress to certify state Electoral College votes for President of the United States, one representative presented his five-minute "objection" to the elector certifications of Georgia, Michigan, Pennsylvania and Wisconsin.

His argument did not concern Dominion voting equipment algorithms or other ballot irregularities which have been the subject of hearings and challenges in many states.

Instead, Dan Bishop (R-N.C.) boldly rose to lay out his case saying, "In the 2020 election, the national Democratic Party carried out a highly coordinated, massively financed, nationwide campaign to displace state regulation of absentee ballots by means of a flood of election-year litigation."

Bishop charged, "This effort was designed to overwhelm the judicial system and disrupt the administration of the election."

"In support of the effort, Democrats' national litigation leaders employed unethical procedural jockeying, including forum shopping, repetitive suits and collusive settlements with cooperating Democrat officials, state and local."

He exposed the Democrats' massive effort to steal the election—even detailing how they did it!

"The Democrats' objectives were to weaken ballot security, undermine positive identification of voters, and provide opportunities for post-election ballot-box stuffing. This has been a national, partisan attack on the Constitutional delegation of authority to regulate elections specifically to state legislatures."

Bishop explained that the Democrats' campaign of litigation has tainted some states' elections.

"I consider this to be an obligation of utmost gravity, predicated on my oath to defend the Constitution, and I hope that the controversy at hand will lead to restoring

Sen. Colbeck's Eyewitness Account Of Election Aftermath Presented to Nov Forum

He recounted the hours of verbal abuse, threats and bullying to which the chair of that board, Monica Palmer, was subjected.

We later learned that a Vermont woman faces federal charges as a result of the woman's action following that Wayne County Board of Canvassers meeting in Detroit.

Colbeck also provided his analysis of vote counting irregularities he had personally observed during the absentee vote counting marathon at TCF Center.

the administration of elections as the Constitution envisions" concluded Bishop.

On May 19, 2020, Michigan Democrat Secretary of State Jocelyn Benson, elected with the assistance of far-left pressure groups, boldly announced that all those listed on the Michigan voter roll would automatically receive a mail-in ballot application without submission of a request.

More Work Ahead For "Unlock Michigan"



Michigan citizens surpassed the goal of 360,000 petition signatures by collecting 539,000 signatures well in advance of the 180-day deadline. and called for repeal of the 1945 statute on which Gov. Whitmer based her emergency lockdown orders.

Since then, citizens have sent hundreds of emails to the Secretary of State Joslyn Benson asking her to do her job of certifying those signatures.

Unlock Michigan continues to work with lawmakers so they'll be ready to vote on the 1945 law as soon as Secretary Benson does her job.

An existing 1976 statute provides for emergency orders limited to 28 days, after which they may be extended with concurrence of the state legislature. That 1976 statute specifically cites disease as a valid reason for emergency action.

After the Michigan Supreme Court ruled Gov. Whitmer lacked the perpetual lockdown authority she claimed, and despite 1976 statutory alternative, the Governor has refused to work with the Michigan legislature, and instead has turned to her Michigan Department of Health and Human Services for implementation of her recent lockdown orders.

The administration's draconian orders and SOS footdragging prompted Unlock Michigan to declare, "There is so much angst right now against Gov. Whitmer, Secretary Benson and Attorney General Nessel.... They have shirked their duties and used their positions for politics and power."

"This is why we all must work now to start the process of removing them from office in 2022."

The group promises free Citizen Leadership Zoom classes so that voters can better understand how the legislative process works, how to build coalitions, and how to be effective grassroots activists.

If you have not "tuned in," here's a quick summary recent Forms:

Three current judges and Mary Kelly, candidate for Michigan Supreme Court, spoke at the ERC virtual forum on Oct. 20.

The four shared about the judicial system and answered audience questions. All were candidates on the nonpartisan ballot.

All the three incumbent judges were reelected on Nov. 3, while Mary Kelly, candidate for Michigan Supreme Court, was not.

Joining that discussion along with Kelly were Judge Christopher Murray, Chief Judge Michigan Court of Appeals, Judge Anica Letica, Judge Michigan Court of Appeals, and Judge Edward Joseph, Judge Third Circuit Court.

On Sept. 15, five of the 18 candidates for the Grosse Pointe Public School System Board of Education addressed the ERC forum.

The candidates were vying in the Nov. election for five BOE openings.

Four were elected to full, four-year terms, while one was elected to fthe remaining two years of a four-year term.

Speaking Sept. 15 were Ahmed Ismail, Lauren Nowicki, Cindy Pangborn, Lisa Papas and John Steininger.

Of those, Ismail and Papas were elected in Nov. balloting, along with David Brumbaugh, Colleen Worden and Joseph Herd. As a result, five of the sevenmember board are newly elected.

On May 19, two republican candidates for U.S. Congress spoke at the Eastside Republican Club virtual forum.

Both were eager to challenge incumbent U.S. Congresswoman Brenda Lawrence (D-Southfield) and to explain why they believed Lawrence could be vulnerable.

The challengers were R. Vance Patrick and Daryle Houston, both on the Aug. 4, Republican Primary Election ballot, vying for the opportunity to challenge Lawrence in the General Election to represent Michigan's 14th Congressional District, which includes the Pointes, and parts of Detroit and Oakland County.

Winning the August primary was Patrick, a Detroit native, Southfield businessman and community volunteer who successfully led the seven-year fight to reopen the Belle Isle Aquarium.

Nov. 3 election results returned the incumbent to office.
